BREEDER'S STAKE



Breeders and Co-breeders must be members in good standing of the GSPCA to nominate a litter for the Futurity at time of Nomination. Owners and Co-owners of Futurity entries must be members in good standing of the GSPCA by JULY 31st (the year of their Futurity)

FUTURITY 63 to run in October of 2026 (For litters whelped between Oct 1, 2024 and Sept 30, 2025) & **FUTURITY 64** to run in October of 2027 (For litters whelped between Oct 1, 2025 and Sept 30, 2026) are now accepting nominations for litters. *Litters must be nominated within 56 days of whelp (\$30). If nominated within 57-112 days, there is a \$70 penalty added (\$100 total), if nominated within 113-143 days, there is a penalty of additional \$170 (\$200 total), No nominations accepted after 143 days.*

The re-nomination of an individual puppy is \$15 by JULY 31st (the year of their Futurity). After July 31st there is a \$85 penalty (\$100) if paid by AUGUST 21st. No puppy can be renominated after AUGUST 21st (the year of their Futurity). No nomination is accepted without official AKC name and number. "Pending" is not sufficient. Due dates are calculated by postmark or date finalized online.

NATIONAL FIELD FUTURITY POLICIES

The German Shorthair Pointer Club of America Board of Directors determines National Field Futurity Policies.

PURPOSE

The purpose of the Breeders' stake is to promote Shorthair progress by thoughtful breeding.

ELIGIBILITY

1. The breeder must nominate the litter within 56 days (8 weeks) of whelping. Nomination is made with the Futurity Manager via US Mail or Online, www.GSPCA.org. There is a \$30.00 fee. All breeders and co-breeders (if applicable) must be current members in good standing of the GSPCA at the time of Nomination. After 56 days – if nominated within 57-112 days there is a \$70.00 penalty charge (\$100 total). If nominated within 113-143 days, there is an additional penalty of \$170 (\$200 total). No litters may be nominated over 143 days after whelp. The Futurity manager will email the breeder a receipt for nomination for the litter. Re-Nomination/Second Forfeit Form can be downloaded from the GSPCA website or payments can be made online.

2. An individual puppy from nominated litters must be re-nominated by the owner by JULY 31st (the year of their Futurity). Re-nomination/Second Forfeit is made with the Futurity manager via US Mail or Online. There is a \$15.00 fee. The owner and co-owners (if applicable) must be current members in good standing of the GSPCA by JULY 31st (the year of their Futurity). The puppy must be registered with the AKC. Re-Nomination/Second Forfeit can be made up to 21 days late with an \$ 85.00 penalty charge (\$100 total). No puppy may be Re-nominated/Second Forfeit after AUGUST 21st (the year of their Futurity). The Futurity Trial Secretary sends a list of entered puppies to the Field Futurity Manager for vetting.

3. Eligible puppies are entered by the Puppies' owner in the Field Futurity using the entry form provided by the GSPCA National Field Trial Secretary. All puppies entered in the GSPCA National Field Trial must include a valid AKC or UKC/FDSB DNA Profile number with their entry.

FUTURITY FIELD EVENT

The Field Futurity event is run each fall in conjunction with the GSPCA National Field Trial. All owners and co-owners (if applicable) must be members in good standing of the GSPCA before JULY 31st of the Futurity year. **Both the Puppy Nomination/Second Forfeit and GSPCA membership will be due by JULY 31st.** The National Field Trial Committee manages the Field Futurity under AKC regulations. The Futurity is not an AKC Stake. The committee selects the judges, marshals, bird planters, sets the date, entry fee, course & running time, produce & distribute premiums, receive entries & fees & draws the running order. The entry fee is established yearly & is used to pay all direct and indirect expenses of the Futurity program and event. The Field Futurity event is a thirty-minute stake judged for consistency & future potential as either an All Age or Gun Dog. Dogs must find & point birds on course. A blank cartridge is fired but steadiness to wing & shot is not required. The Field Futurity event is not a retrieving stake.
